I could tell you a good story of an Irish gentleman here if it was not too indecent for a modest man to relate very circumstantially.¹¹ Mr Richards¹² is the name of the gentleman; the lady¹³ is Italian, a woman of fashion and said to be very homely. To go from the Prince of Conti's she imprudently accepted a place in his coach. He did not lose an instant in endeavouring to improve the opportunity. He drew upon her before the coach was out of the yard. She defended herself by saying there were then strong reasons against it, to get rid of him; but that was not sufficient for Irish ardour. He was determined as he said to pass *outre*, upon which she was reduced to cry out for protection, and the story as you may imagine is well told amongst the ladies who can relate decently.

I have been soliciting to obtain for a person of my acquaintance here the last papers which d'Éon has published,¹⁴ by which I suppose is meant all that he has published since his first large work;¹⁵ what it is I do not know. Be so good to inform me what they are and to obtain them for me if it is easy. Pray who is the Chevalier Stapleton¹⁶ that is minister from some German court in London?
